LIST OF AWARDS AND CRITERIA:

1) Clinician of the Year

Eligibility	Primary member of the Department of Cardiac Sciences
Criteria	Excellence in patient care, Superlative technical skill, Quality Improvement, Innovation in education or research, Positive attitude and genuine empathy towards patients and co-workers. Outstanding contributions to the Department of Cardiac Sciences, and by doing so has represented Alberta Health Services, the University of Calgary and the Libin Institute at the highest level
Who can nominate	Any member of the Department of Cardiac Sciences (clinician, operations or administration), residents or fellows.

2) Department of Cardiac Sciences Achievement Award

Eligibility	Primary member of the Department of Cardiac Sciences to include but not limited to: Nurses, nurse-practitioners, clinical assistants, Technologists, IT staff, unit clerks, administrative assistants, operational leadership. NOT a physician member of the medical staff.
Criteria	Excellence, innovation, teamwork in activities that improve patient-centered care will be the driving force behind the award. Outstanding contributions to the Department of Cardiac Sciences, and by doing so has represented Alberta Health Services, the University of Calgary and the Libin Institute at the highest level
Who can nominate	Any member of the Department of Cardiac Sciences (clinician, operations or administration), residents or fellows.

3) Dr. Peter Russell Memorial Award

Eligibility	Clinical Cardiology Fellow
Criteria	Exemplifies Dr. Peter Russell's passion for medicine and patients.
Who can nominate	Any member of the Section of Cardiology, residents and fellows

4) LB Mitchell Fellowship Award

Eligibility	Department of Cardiac Sciences clinical trainees: Residents and Subspecialty Fellows
Criteria	To be distributed to training programs. <i>NB: Individuals are only eligible to receive this award once.</i>
Who can nominate	Self-nominated. Residents and Fellows will apply for this award.

5) Libin Researcher of the Year

Eligibility	Primary appointment Libin Cardiovascular Institute.
Criteria	Excellence in research productivity or academic innovation will be the driving force behind the award.
Who can nominate	Can be self-nominated or by any one member of the Department of Cardiac Sciences and/or the Libin Institute.

6) Todd Anderson Cardiovascular Research Award

Eligibility	Primary appointment Libin Cardiovascular Institute. Early career researchers (MD and PhD within 10 years of first faculty appointment – preference to first 5 years)
Criteria	Evidence of commitment to research in the area of cardiovascular health and disease; academic excellence; significance and quality of proposed project
Who can nominate	Can be self-nominated or by any one member of the Department of Cardiac Sciences and the Libin Institute

7) Henry J Duff Libin Cardiovascular Institute Supervisor of the Year Award

Eligibility	The recipient of the award can be a researcher with a focus within or between any of the research pillars. Nominees of any academic rank are eligible.
Criteria	This award is for a great research supervisor in the Libin Cardiovascular Institute at the University of Calgary.
Who can nominate	The nominations can come from faculty, students and staff of the Libin Cardiovascular Institute. Self-nominations are allowed. The same person cannot win the award within 3 years of previously winning this award.
